The Associate in Science Degree in Paralegal Studies is designed for students seeking a professional career in a law-related field. The program trains students in many diverse areas of law. Subjects include legal research and writing, real estate law, criminal law, family law, wills and trusts, torts, and litigation. This degree is approved by the American Bar Association.

Graduates of Edison State College AS degree in Paralegal Studies will be specialists who can manage law office operations, assume certain routine duties of attorneys and directly assist attorneys in handling legal problems. Other roles may include performing legal research, developing new procedures, and drafting of documents. The program, requiring 64 college credit hours, is designed for both full and part time students. Classes are offered in day, evening, and Saturday schedule formats throughout Edison's five county district.

Graduation from this degree program does not qualify students to practice law, sit for a state bar examination, nor represent themselves as lawyers. Paralegals and legal assistants are advised to understand and acknowledge the American Bar Association definition of a paralegal or legal assistant as "a person, qualified by education, training or work experience who is employed or retained by a lawyer, law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal work for which a lawyer is responsible." Paralegals and legal assistants may not act as/or represent themselves as lawyers.

Students intending to continue toward a Bachelor's degree are encouraged to choose electives recommended for university transfer. The Associate in Science degree in Paralegal Studies transfers directly into the Edison State College Bachelor of Applied Science degree in Public Safety Administration.

Tuition and Fees

Edison State College is a comprehensive public college. The cost per credit hour at the time of this publication is \$89.88 per credit hour for Florida residents and \$333.40 per credit hour for non-Florida residents. Other fees may include \$30.00 for an initial application fee, as well as applicable lab fees and textbooks.
